LISTSERV RULES AND CONDITIONS SUBSCRIPTION FORM

The following are the rules and conditions of participation in the Virginia Women Attorneys Association listserv. By subscribing to and participating in this listserv, users hereby agree to be bound by and warrant their full compliance with the following terms of participation:

This listserv is a service provided by VWAA in furtherance of its nonprofit and tax-exempt purposes. Specifically, this service is provided to further VWAA's mission to provide education and information for women attorneys for the purpose of improving and developing their capabilities. The VWAA listserv has been established as a means of allowing VWAA members to have discussion and share ideas regarding the practice of law in Virginia, the activities of the VWAA, legislative developments of interest to the members, and general legal news.

All postings shall be of an informational nature and for informational purposes only. Commercial use or any other unauthorized use of this listserv is prohibited. Do not use the listserv to solicit or conduct business, including the direct or indirect marketing of users' products or services, in any manner. The listserv may not be used to provide information, materials, products, or services in exchange for compensation of any kind. The VWAA listserv is a closed subscription service for the Membership. Therefore, only VWAA members may use the listserv. Those not eligible will be removed and/or precluded from subscription.
